Dhanani has in his plea said that the distribution of Remdesivir injection by Paatil and Sanghavi is illegal and violates several provisions of the Drugs and Cosmetics Act, Pharmacy Act, and Drugs Control Act among others. Modi pointed out that the first reform under the 'One Nation One Ration Card' policy required state governments to ensure that all ration cards in the state under the National Food Security Act (NFSA) were sponse to the COVID-19 pansponse to the COVID-19 pandemic, we wanted to ensure that our solutions do not follow a 'one size fits all' model. For a federal country of continental dimensions, finding policy instruments at the national level to promote reforms by State governments is indeed challenging," he said. "But, we had faith in the robustness of our federal polity and we moved ahead in the spirit of Centre-State bhagidari," he said in his post titled "Reforms by Conviction and Incentives".

Additional borrowing of 0.15 per cent of GSDP was linked to this, he added, Modi said 12 states added Modi said 13 states implemented at least one component, while 6 states implemented the DBT component, and as a result, Rs. 13,201 crore of additional borrowings was permitted. "Overall, 23 states availed of additional borrowings of Rs. 1.06 lakh crores out of a potential of Rs. 2.14 lakh
