



# Over 2.11 cr COVID-19 vaccine doses available with states, UTs and pvt hospitals: Govt

**NEW DELHI, JULY 20** / More than 2.11 crore COVID-19 vaccine doses are still available with states and union territories (UTs) so far, through all sources, and 71,40,000 doses are being supplied, it said. Of this, the total consumption, including wastage, is 40,03,50,489 doses, according to data available at 8 a.m. in the ministry said.

It said that 2.11,93,241 balance and unutilised COVID-19 vaccine doses are still available with states and UTs, and private hospitals.

## Chhattisgarh: villagers untraceable in Sukma; Naxal hand suspected

**RAIPUR, JULY 20** / At least seven people from a village in Chhattisgarh's Sukma district are untraceable since the last two days and are suspected to have been abducted by Naxals, police said today. In another incident, Naxals killed a former colleague who had quit the outlawed outfit in Bijapur district, it said. In the insurgency-hit Sukma, seven people were recently picked up by ultras from separate localities, while one approached the police at Jagargunda police station limits, Sukma Superintendent of Police Sunil Sharma said.

"It is still not clear whether the villagers were abducted by the rebels or they voluntarily went with them, he said. As per preliminary investigation, the seven people were picked up by ultras from the village, while the locals claimed they went to other places to attend a marriage function and for agricultural purposes, the official said. Efforts were on to trace them, Sharma said. So far, no FIR has been lodged from the village, while no one approached the police, the official said, adding that they got to know about these

Padeda village under Kotwali police station limits, he said. The body, bearing injuries inflicted by sharp weapons, was found lying on a road near the village on Tuesday morning, the official said. After being alerted, a police team rushed to the spot and the body was sent for postmortem, he said. As per preliminary information, the deceased, who was associated with banned CPI (Maoist) for a long time, returned to his village a few years back and since then he was doing farming, the official said. The victim had not officially surrendered before authorities, he said.

A search operation has been launched to trace the ultras, he added. With this incident, Naxals have so far killed three persons in separate incidents in Bijapur this month. In October last year, the outlawed CPI (Maoist) had claimed the responsibility for killing 35 people, including some of its cadres, in separate incidents in Bijapur district for allegedly acting as police informers. The rebels, however, had not disclosed when the killings took place. According to police, all those killings took place during August, September and October last year. (PTI)
